FIRST AID

If Swallowed: Call a poison control center or doctor immediately for treatment advice. Have the person rinse mouth and sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

GENERAL INFORMATION

MICROYL is a unique activator adjuvant that provides superior performance and improved turfgrass safety at lower use rates when compared to ordinary crop oil concentrates.

FOR USE WITH PESTICIDES REGISTERED FOR GOLF COURSES, SOD FARMS, RECREATIONAL, COMMERCIAL AND RESIDENTIAL TURFGRASS AREAS, AS WELL AS SPORTS GRASS PLAYING SURFACES AND NON-CROPLAND.

DIRECTIONS FOR USE

The addition of adjuvants to some tank mix combinations may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using MICROYL, the applicator or crops advisor must have experience with the tank mix combination, including MICROYL, or must have conducted a phytotoxicity test. Do not use this product in a manner inconsistent with labeling.

MICROYL increases the activity of many pesticides; therefore, care must be taken when treating sensitive crops during periods of drought stress, high temperatures or high humidity.

USE RATES

By volume: Apply at 0.375–0.5% v/v (3–4 pints of MICROYL per 100 gallons of spray solution).

By acre: Apply at 10–12 ounces per acre in a volume of water sufficient to provide coverage.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature and shake or recirculate before use. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
