Terms and Conditions:

- **01.** A product qualifies when the minimum quantity of that brand is purchased between October 1, 2023 and March 31, 2024.
- **02.** Any rebates submitted and verified by April 30, 2024 will be paid by July 2024. Any rebates submitted by after April 30, 2024, will not be accepted.
